

## South Atlantic Prep Boxing Tournament To Be Held March 5 and 6

38 Entries Have Already Been Received; Others are Expected

The annual South Atlantic Preparatory School Boxing Tournament will be held at the Staunton Military Academy on March 5th and 6th. The bouts will begin on Friday evening at 7:30, at which time the preliminaries will be held. The semi-finals will be held Saturday afternoon beginning at 2:30, and the finals will begin at eight o'clock Saturday night.

Of nine tournaments held, S.M.A.'s team has emerged victorious in eight, losing only once the invitation tournament held at the University of Virginia in 1930 to the Augusta Military Academy. The Staunton team was runner-up in this, the only tourney in which they have been defeated.

Immediately following the weighing-in on the gymnasium floor of Memorial Hall by the referee-in-chief, the contestants will be served steak dinners in the S. M. A. messhall, and all coaches will meet with officials of the Tournament for the drawings, which will be supervised by an impartial official, Mr. O. L. Denton.

The eight winning boxers in the finals will receive gold medals, and the eight runners-up will receive silver medals. The winning team will be awarded a gold cup, appropriately engraved and stamped with the official Tournament die, and the runner-up team will receive a similar silver cup. The coach and manager of the winning team will receive gold medals, and likewise the coach and manager of the runner-up team will receive silver medals. Points toward the team championship will be awarded as follows: 5 points to the winner in class; 3 points to the runner-up.

As yet, there are but thirty-eight definite entries to the tournament. However, many of the schools invited to enter have not yet entered their applications, all of which must be in before Tuesday, March 2. Those schools which have already signified their intention of entering the bouts are as follows: Augusta Military (full team); Staunton Military Academy (full team); Hargrave Military Academy (full team); Miller School (five men); Charlotte Hall School (four men); Randolph-Macon Academy (four men); Baltimore Poly H. S. (one man).

Three referees have been invited to referee and judge the Tournament, but none have been heard from so far. These are Mr. Ed Brockman of Baltimore, Mr. Allie Wolf of New York, and Mr. Elder Craft of Portsmouth, Virginia. All three men will take turns in refereeing the contest, while the others judge.

## Calvin Griffith Made President of "Lookouts"

Calvin Griffith, twenty-five, and an adopted son of President Clark Griffith, of the Washington Senators, a former student at S. M. A., where he caught on the baseball team and also captained the club, has been named president of the Chattanooga, Tenn., Lookouts to succeed Joe Engle.

While not attending to his school duties at S. M. A., young Griffith, who was adopted by the Washington baseball man at the age of ten, was assigned minor duties around the Senator park until it was felt that he was equipped to take over the seriatim duties of the Lookouts two years ago.

A pitching star, himself, at George Washington University, Calvin was often sent on scouting tours by Mr. Griffith, who has long held fondly the hope that the youth would succeed him as president of the Washington Club. Two years ago he was sent to the Chattanooga Club as secretary.

## Real Old Timers Of Forty Years Ago Tell Something Of Staunton In The Nineties

### Members of the Class of 1896 Now Prominent Citizens of Texas

The above photograph of a group of Staunton cadets of the class of 1896, was sent to The Kablegram by Mr. James F. Minor, of the class of 1893. At the time the photograph was made Mr. Minor was an instructor at S. M. A. A letter from him is printed in an adjoining column. The photograph is the property of Mr. Robert Hewlett, S. M. A. 1896, and was made in New York Harbor in June, 1896, on board a Mallory Line boat which plied between New York and Galveston, Texas. The cadets were a group of Texas boys who were about to return home for the summer vacation.

Letters were sent to each "boy" in the photograph, and also to Mr. Minor. Replies have been received from Messrs. Howard, Royall, and Minor.

Messrs. Townsend and Lidstone are dead, according to information received by The Kablegram. Mr. Hewlett lives in Cold Spring Harbor, New York. Excerpts from the letters from Dr. Howard and Mr. Royall are printed below.

"A. Philo Howard, M.D., chief surgeon, Burlington-Rock Island Railroad Co., Houston, Texas," reads the letter-head from Dr. Howard. His letter follows:

"Your letter of December 18, with regard to a picture which you have. That was taken in June, 1896, by Robert Hewlett, on board a Mallory Line boat in the harbor at New York, when some of us Texas boys were sailing from New York, to Galveston, at the end of our school year. With regard to the identification, you seem to have them all, with the exception of Lamar M. Lidstone, who was later president of the First National Bank at San Saba, Texas, and died there a few years ago.

"With regard to myself, I entered the University of Pennsylvania in September, 1897, and graduated in 1901, with the degree of Doctor of Medicine. I did an internship in Philadelphia, and later went to St. Louis, as demonstrator of anatomy in St. Louis University. In 1907 I was made chief surgeon of the Frisco Lines in Texas and Louisiana and moved to Houston, Texas. I have a son who graduated from S. M. A. in '31—Ryland Howard.

"The picture does not show the complete class and I cannot think of all of them, but below I am giving those I can think of:

"Kable, of Illinois; Goodlow, who lived on the mountain between Staunton and Charlottesville; Alec Harris and Will Sedwick, of Waco,

### Member of Faculty of '96 Who Is An Alumnus of '93, Writes Memoirs

At the request of The Kablegram, Mr. James F. Minor, S. M. A. 1893, who also was an instructor at the Academy in 1896, sent us his recollections of the school at the time he was associated with it. As is stated in the adjoining column, Mr. Minor sent us the photograph of the group of graduates above. Mr. Minor lives in Charlottesville, Va., where he is the proprietor of a general insurance business. His letter follows:

"I enclose a kodak picture taken back in 1896 of five S. M. A. boys shortly after their graduation. I received it from Mr. Robert Hewlett, Cold Spring Harbor, N. Y. I was teaching at S. M. A. that year, and this was part of the graduating class.

"When I taught at S. M. A. for the session of 1895-6 I was a youth of nineteen years. There were only seventeen boarding pupils on the hill. Old Captain Kable, "Kid" Kable (the late Capt. W. H. Kable), A. A. Hooff, and myself, were the faculty. We had a football team, though, with some boys from town playing on it, including Col. Harry N. Cootes, U. S. A., Horace Peck, William Trout, and Bill Geiger, and we licked Roller's (A. M. A.) I think. I had a room at the end of the old wing that used to stick back from the residence of Captain Kable, and young Captain Kable and Hooff had rooms in the old frame barracks on the parade ground with the gymnasium under it. The school was held in the old school house, which stood south of the barracks. There was also a teacher, a big fellow who could not control the boys. I remember once there was a great commotion in his classroom and Captain Kable left the desk in the assembly hall and strode into the room to find the boys climbing all over the teacher. The riot was stilled at once on Captain Kable's

## Colonel Middour Attends Educational Conference

Colonel Emory J. Middour, Superintendent, is attending the twelfth annual conference of the Secondary Education Board held at the Commodore Hotel, New York City, today and tomorrow. This conference from year to year solicits the interest and representation of the better known Eastern preparatory schools. In the conference for this week the subjects of the Secondary School program, its administration, its religious education and its general management, including both the senior and junior schools, will be made subjects of study. There will also be a discussion of the part that music, work in the shop and studio, should take in the secondary school program. The final session of the conference will be devoted to a study of the future trends of examination procedure. This discussion will be directed by Mr. John M. Stalneck, research officer of the College Entrance Examination Board. This conference gives Staunton an opportunity to compare its program with the program now being followed and advocated by the best Eastern preparatory schools. Men representing St. George School, the Hill School, Phillips Exeter, Deerfield Academy, the Taft School, Avon Old Farms School, Yale University, Princeton University, William Penn Charter School, the Kent School, St. Paul's, and many other leading Eastern preparatory schools will participate in this conference and share with one another their experience and success in deciding what is best and wisest in the field of secondary education.

### General Letter to Parents From the Superintendent

Dear Friends:

Since this issue of The Kablegram goes to all parents of the present cadet corps, please permit this general letter. The past two months have been difficult and trying both for the cadets and all of us in the organization of the school. As you know, three out of every four days since Christmas were cloudy, rainy days. This weather did not help the spirit of the boys who had had a very happy and free Christmas vacation and then on their return found that they were again back in the regular routine of school work for a period of five months. We make our year less troublesome and less expensive for parents by running through the second term without interruption and by dismissing school two weeks earlier than other Eastern preparatory schools. Staunton has found this plan more successful.

We were unfortunate in having a mild epidemic of flu following the Christmas holidays. Although there were fifty-five boys in the infirmary at one time, no boy was seriously ill and each boy, after several days' illness, returned to his regular duty. This interruption just before the examinations for the second quarter took its toll in the results of the exams. We are hoping that nothing will interfere with the work of the third quarter and that the boys who were handicapped by illness will be able to make up any loss they suffered during the flu epidemic. I have tried to encourage each boy to do his best, for when a boy uses his time wisely, takes an aggressive attitude towards his work, and does his best, then the year becomes a very successful and profitable one for that boy.

As you know, we have set aside Monday, March 29th, as "Parents' Day" at Staunton. I hope that you will plan to spend Easter with your son and that you will remain over with us for Parents' Day on Monday, March 29th. Since the cadet corps is much larger this year and we shall doubtless have a number of guests on that occasion, I am sure you will understand that it is our wish to take

Monday, March 29, has been set as the date of "Parents' Day" at Staunton for this year. In his general letter to parents, printed in another column of this paper, the Superintendent issues an invitation to all parents of cadets in the corps to spend Easter with their sons and remain over for Parents' Day on the following Monday.

All parents are invited to dine with the corps on the 29th, and to attend the formal dance to be held in the evening. Other events scheduled for the day are a dress parade by the cadet corps, and a reception by the faculty for the parents in the school library.

As was explained last fall in the first announcement of Parents' Day for this year, the date was changed from Thanksgiving to Easter time, because it seems better to break the long term from Christmas until June by this function than to have it during the short fall term. Also since Easter marks about the middle of the spring session, and it is customary to give the corps a holiday on the Monday following Easter, this date seems all the more appropriate for this occasion.

## James Cochrun Is Cited By Gen. John J. Pershing

James Cochrun, S. M. A. 1933, who is a senior at Ohio Wesleyan University, Delaware, Ohio, was decorated last week by General John J. Pershing for "Excellent military bearing and aptitude." He received this award at Washington, D. C., February 18, and was congratulated by President Roosevelt.

Last July, Cochrun attended the military encampment at Fort Benjamin Harrison with 2,000 others from Ohio, West Virginia, and Indiana, known to the War Department as the Fifth Corps Area. He was selected as the most outstanding member of this group.

Recently the war department sent Cochrun a notice which declared him the most outstanding member of the Fifth Corps Area for the year 1936 and requested his presence at Washington for the week-end of February 18-20. He paid a short visit to S. M. A. on his trip to Washington.

## Players and Coach Attend Football Banquet at U. of Va.

Cadets Brackman, Jones A., Shaw, Traut, and Wilson, all members of last season's S. M. A. football team, accompanied by Head Coach Howie, attended the second annual state interscholastic football banquet generously tendered them and 150 other preparatory and high school gridmen and their coaches on Saturday evening, Feb. 20, in Madison Hall at the Univ. of Va., as honored guests of the University Varsity Club and the Charlottesville Alumni Chapter.

After witnessing the presentation of the 1936 football championship awards to Fork Union Military Academy, Episcopal High School, and Hampton High School at the close of the banquet, the entire interscholastic group was escorted to Memorial Gymnasium as honored guest spectators among the capacity crowd of 5,000 gathered to watch the Harvard-Virginia boxing match, which resulted in a triumph for Virginia, captained by Fred Cramer, S. M. A. class of 1933, former blue and gold champion heavyweight boxer, who finished his collegiate ring career in a blaze of glory by scoring a technical K. O. over Howe of Harvard in the first round.

#### MEMBER OF BOARD OF TRUSTEES SUCCEDES

Judge William A. Pratt, a member of the board of trustees of Staunton Military Academy, died early in January, after a brief illness. Judge Pratt was one of Staunton's most successful business men. He was president of the National Valley Bank here and prominent for many years in the legal and civic affairs of Staunton. Judge Pratt had been a member of the board of trustees of S. M. A. since 1934.

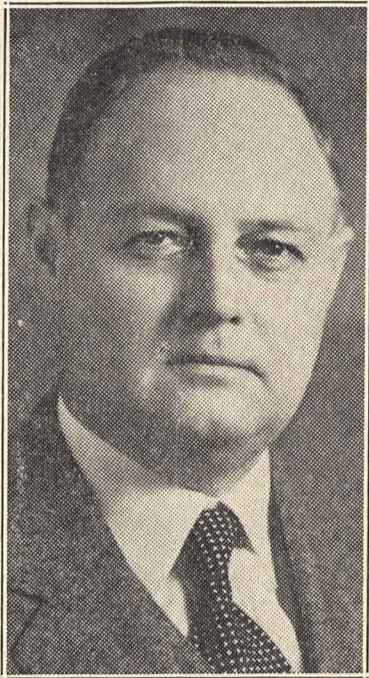

15, 1893, and received his secondary education in Staunton public schools and at Staunton Military Academy, where he was graduated in 1911. He was graduated from the University of Virginia law school in 1917, after an enviable record, which included election to Chi Phi fraternity, Phi Delta Phi, the legal fraternity, P. I. L. K. A. ribbon society, and the Raven Society, the latter a recognition of high scholastic attainment. He served on the editorial board of the Virginia Law Review, and was secretary-treasurer of his class.

After practicing law in Richmond and Staunton, Mr. Crosby was elected commonwealth's attorney at the age of twenty-nine, which position he resigned to become trust officer of the National Valley Bank of Staunton, which position he had until his appointment as judge last month.

Mr. Crosby has shown a keen appreciation of civic responsibility and has served the community in many ways. He has been a vestryman in his church since 1920. He has also been a member of the city Democratic committee and was chairman for a number of years.

About the only claim I have to the Hall of Fame is my friendship with Billy Mann (whom you featured in a recent issue). Am happy to say our friendship has endured through the years. Speakin' of Mann, now there is a fellow with the determination of the Devil. Had he set his heart on becomin' President of Vassar for instance, he would have accomplished it; his desires, however, ran in a slightly different direction. He preferred the "Big Cats."

Mr. Royall's letter-head reads: "First National Bank in Dallas, Capital \$8,000,000. Surplus \$2,000,000. Tucker Royall, chairman of the board." Mr. Royall has been connected with the above institution since 1897. The following is quoted from his letter to The Kablegram:

"I graduated from Staunton Military Academy in the summer of 1896, and from there went to the Eastman National Business College of Poughkeepsie, New York, where I graduated, received a diploma, and later took a special course in banking. 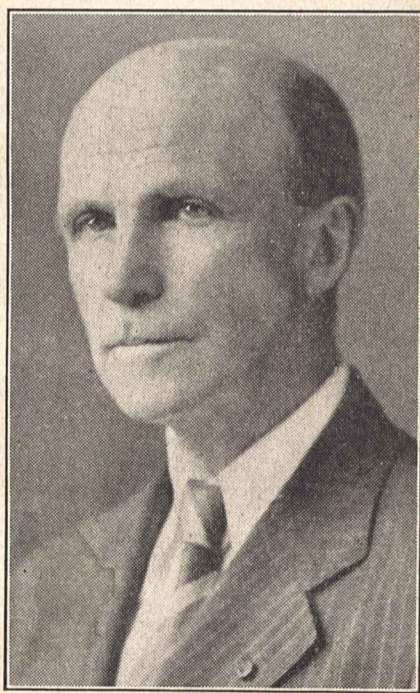

A LITTLE BIT OF EVERYTHING

**TABLE MANNERS**

Dear readers, I have some very valuable information for you this time. At one time or another you are going to have to eat at our school mess. Then, if you do intend to eat, you must have elementary rules concerning the proper use of your eating implements.

Let us take the most deadly weapon first.

The knife should be placed (before seats) with the handle projecting about three and a half inches from the edge of the table. This is to help you make a quick draw when "seats" are given. Since it is very necessary that you have the use of both your hands, I would advise that you hook your feet in back of the front legs of the chair and give a slight hump forward. 4—My Own Situation: The distance of the "Spuds" as to the Meat, and which to go after first. What to try and get first, and the best method for doing same.

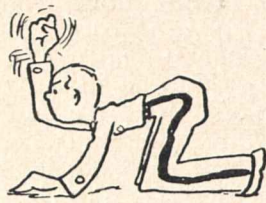
5—The Decision: This means the plan that you finally adopt, after careful consideration for all elements of the problem.

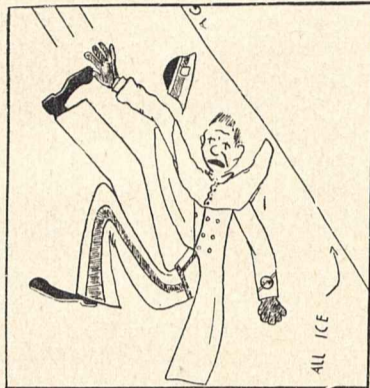

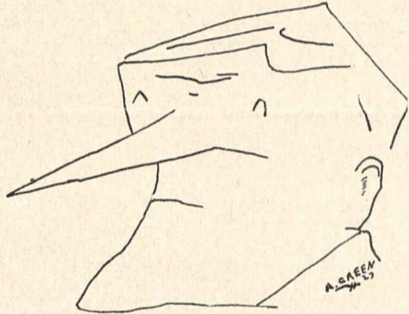

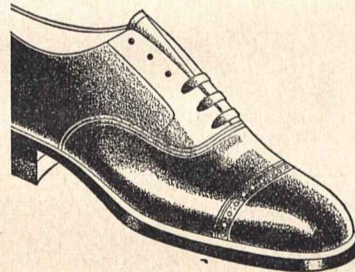
